AGM – September 28, 2014

Our number of competitors in our events rose to 207 from 194.

Our <u>Youth Challenge</u> Black team captured the bronze medal under the guidance of Terry Ell. Linda Seitz was selected to coach at nationals where our team ended in the silver position.

In the <u>Pins Over Average</u> we once again sent a team to the nationals from Rocky Mountain House and Red Deer with Linda Seitz serving as coach. Unfortunately they finished in 8th place in the A pool and were eliminated from competition. The previous year we took bronze at nationals and the year before that the silver.

In the **<u>Open</u>** Gary Baird won the men's singles at provincials coming from 5th to knock off Shelby Chrest in 4th, plus the other three contenders.

On the ladies singles Barb Taillon was 4th in qualifying, then went all the way to the championship game before losing.

Gary represented the province at the Open Nationals finishing 3rd in the men's singles round robin, before losing out in the stepladder.

In team competition our mixed team was 2nd, the men finished in 3rd, the women in 4th.

At the **<u>high low</u>** our best teams ended 2nd and 4th with our second place team losing the event by just 7 pins.

Past president <u>Eric Andersen</u> was awarded the Alberta Grassroots Coach of the Year, and then was presented with the Canadian award at the Canadian Open Championship held in Calgary. Eric is to be commended on a long association with coaching as well as serving on the Central executive for a lengthy period of time.
